* Residence within 30 Miles must meet one of the 3 categories to be eligible:

1. Attend local primary and or secondary schools for at least 5 years.

3. Being domiciled as a taxpayer eligible to vote and filing taxes from an address in a 30 mile radius for >5 years



APPLYING FOR MEMBERSHIP AT WYANTENUCK COUNTRY CLUB

The following guidelines and information are available to assist applicants in the application process and other information about Wyantenuck County Club.

FORMAT:

- ❖ Complete the application form indicating the membership category (golf, tennis, pool and/or social) you are applying for.
- ❖ The application should list the two voting member sponsors for your application. Those two members will be sent sponsorship forms to be completed and mailed to the Club. Please check with Jennie to ensure the sponsorship forms have been received and your application is complete.

APPLICATION PROCEDURE:

- ❖ The application is presented to the Membership Committee who reviews and recommends the applications to the Board of Governors for their final consideration and vote.
- ❖ Applicants are informed of the status of their application in writing. If necessary, any further information required by the applicant will be stated in this letter.

BREAKDOWN OF FEES AND PAYMENT PROCEDURES:

- ❖ The Initiation Fee is a one-time, non-refundable fee. Only one initiation fee is charged regardless of the number of categories accepted.
- ❖ The House Minimum is due on March 1st. All food and beverage charges are applied to your house minimum balance. The House Minimum is either the single or family rate depending on the category requested and is a yearly fee.
- ❖ Membership Dues (i.e. golf, tennis, pool and/or social) may be paid in full or in five equal installments from May 1st to September 1st and are due yearly.
